

# TRANSITION BILL OF RIGHTS

Students in public schools with an **Individualized Education Program** (IEP) have certain rights under both federal and state laws. This **Tennessee Transition Bill of Rights** will help you understand the laws and rights related to your son or daughter's education. The ultimate goal is to help you advocate for your child's **successful transition** from high school into adulthood.

**Starting at age 14**, students with a documented disability in Tennessee have the right to...

Under the **Individuals with Disabilities Education Act** (IDEA), a law that ensures students with disabilities receive a free and appropriate public education (FAPE) in the least restrictive environment (LRE)

- Participate in making decisions around post-school goals, annual IEP goals, accommodations, and modifications included in the IEP.
- Develop meaningful post-school goals related to employment, education/training, and independent living (if appropriate). These goals should be based on age-appropriate transition assessment(s) and reviewed annually by the entire IEP team (including the student).
- Receive transition services based on their needs, preferences, and interests. These transition services should start no later than age 16 and should help them meet their post-school goals.
- Identify courses required for earning a high school diploma. Tennessee has four different diploma options ([click here](#)): regular, alternate academic, occupational, and special education diplomas. Each diploma option has different requirements.
- Participate in meetings related to education/training, employment, and independent living interests.
- Be informed about options for supports after school, including supported decision making and guardianship/conservatorship.
- Receive individualized education services through graduation with a regular diploma or age 22 (whichever comes first).

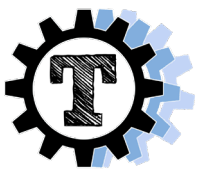
Under the **Workforce Innovation and Opportunity Act** (WIOA), a law that ensures students between the ages of 14-22 with a documented disability (with or without an IEP or 504 plan) receive Pre-Employment Transition Services (Pre-ETS)

- Receive instruction in career exploration, counseling, and skills needed for successful adulthood.
- Receive Pre-ETS in the school, community, and work setting. These may include:
  - Career Exploration
  - Work-based Learning Experiences
  - Postsecondary Education Counseling
  - Workplace Readiness Training, and
  - Instruction in Self-Advocacy
